HOW DOES MEMBERS REWARDS WORK?

Members Rewards provides additional rewards for Castle Hill RSL Members who correctly use their membership card for all gaming, food & beverage, show tickets, events and Castle Hill Fitness & Aquatic Centre. The Members Rewards program is tiered. The more tiering points you earn, the higher the level that can be achieved. Rewards are offered to Members based on their level.

HOW MANY LEVELS ARE THERE?

There are five levels in Members Rewards and each level offers special benefits for Sapphire, Ruby, Emerald, Diamond and Double Diamond.

HOW DO I KNOW WHAT LEVEL I'M IN?

Your member level is displayed when you insert your card in a gaming machine, or swipe at the Members Rewards kiosk. You can also ask a friendly member of our staff to confirm when making a purchase at one of our outlets.

HOW CAN I GO UP A LEVEL?

Each week we will move Members up to the level that they qualify for, based on the tiering points they have earned on their member card.

CAN I BE MOVED DOWN LEVELS?

Yes, but unlike moving up in levels, this will be reviewed every 6 months, in April and October. Once you reach a level, you will not move down until the next review date.

DO BONUS POINTS EXPIRE?

Yes, at the close of business on June 30th each year, all bonus points will expire and reset to zero, with the exception of Double Diamond members.

HOW CAN I USE MY BONUS POINTS?

You can use your points to make purchases within any CHRG venue, as well as to purchase gift cards and other items. Points cannot be exchanged for cash.
